Important things you should know about Change of Registrar

As a .au Domain Name Reseller, Virtual Access is free to deal with a number of .au Domain Name Registrars. Each registrar may offer us different price or service combinations.

In order for existing customers to take advantage of the best pricing on offer for their domain name renewal, it is sometimes necessary for us to require a change of registrar be undertaken. Making this change is optional for our customers, but may be the only way to secure a lower renewal price.

The Australian Domain Authority (auDA) has policies which govern .au names. This request will be processed in accordance with current auDA policies. You can view current auDA policies by visiting <http://www.auda.org.au>.

You do NOT have to complete the form to authorise a change of registrar. If you prefer, we can initiate the process, and you will be required to respond to email requests for confirmation. If you complete this form, we can manage the whole process for you.

If any .au domain is within 3 months of its license expiry date at the time of transfer, a 2 year renewal is processed automatically. We may elect to invoice you and receive payment prior to transferring your domain.
